In a nutshell

b-solutions is an initiative promoted by the European Commission's Directorate-General for Regional and Urban Policy (DG REGIO) and managed by the Association of European Border Regions (AEBR), **addressing legal and administrative obstacles along EU internal borders.**

Its main objective is to **support and promote solutions** to legal and administrative obstacles hindering cross-border cooperation in Europe. It is open to public bodies and cross-border structures facing border obstacles along EU internal, EU-IPA and EU-EFTA land and maritime borders.

Since 2018, over **130 examples of obstacles have been collected** and include among others, issues related to overlapping administrative procedures for medical reimbursement, diverging rules for cross-border use of energy, different laws regulating public transport on the two sides of the border.

An **ongoing call for proposals** is currently open to provide support to actors in border regions: <u>https://www.b-</u> <u>solutionsproject.com/call-for-proposals</u>. Applications are reviewed on a rolling basis and can be submitted in any European language. Selected **cases receive tailored technical assistance from legal and/or administrative experts** familiar with the territory and its languages.




